It is my understanding that Pennsport graciously agreed to replace the Brownie's team for the good of Thursday League. At this point, I do not anticipate receiving any more incoming funds for Fiscal 2023-24 until the Banquet.

On the expense side, I made an ATM withdrawal to pay Pennsport (\$88.50 including ATM fees) for hosting our last Board Meeting, I made a credit card payment to Your League Stats (\$250.00), our annual YLS fee minus a 50% discount, and I made a credit card payment to Google (\$2.15), our monthly fee for additional email storage. Our current balance for Fiscal 2023-24 is \$17,302.01 leaving us with \$36,569.35 in overall funds to the moment.
